Namaste Dear members

It is that time of the year for our festive season with Navratri, Diwali and New Year celebration in October/November 2016. It is also the time of year when we have our AGM for the mid-term of the two year term of office management committee of Hindu Samaj Swindon (HS). Over the years we have seen some changes but during the last few years we have seen some major changes in the population and demographics in Swindon and the UK. Other major changes affecting Hindu Samaj Swindon were:

- a) Location venue for Navratri moved as the Link centre was no longer available.
- b) Since April 2016 the Swindon Hindu Temple and Cultural centre has been established in Cheney Manor by the Swindon Temple Trust (Temple Trust).
- c) HS were already been working closely with the Temple Trust to jointly organise our religious events as the joint events were likely to be more successful than two similar events happening at the same time in the town.

The Swindon Temple now provides for most of the religious events in which HS committee and our membership can participate. During the year we jointly celebrated Mahashivratri, Ramnavmi Hanuman Jayanti and Krishna Janmashthmi. To get the Temple facilities going, HS committee encouraged volunteer support and approved for funds to purchase furniture. Thereafter the Temple also received some additional furniture from the local enterprises. Slowly the Swindon Hindu Temple and Cultural Centre is taking shape and HS members are most welcome to participate in the activity at the centre. Over the last two years HS building project was put on hold while the Temple trust pursued its objective. Now that the Swindon Hindu Temple and Community Centre is established, the recommendation and proposal from the HS committee is to discontinue with the HS building project. This decision has to be ratified at the AGM. We would like to thank all those who supported our building project.

HS management committee has decided to continue representing it's members and also continue with the social and Hindu faith related activities. We will continue holding joint religious events and celebrations at the Temple to avoid duplication. Apart from the joint Hindu festival celebrations above, HS management committee also organized Maya-Deepak musical evening, Holi celebrations and BBQ-Picnic. This year's Sports day is at the Croft Sports centre, Navratri and Diwali celebrations are at the PCC for the membership. Mitra Milan (senior ladies), Young Citizen's (man's) group and soon a similar ladies group continue under each group's self-managed bases. Members are requested to join these group's activity. We also provide representation on SACRE at the SBC and training support for the police recruits and local schools through Inter-faith activity. The revised membership fees and members contribution for some of the social activities will continue. Current bank interest rates are at all time low and that will affect our future revenue. See below our annual accounts status. The management committee would like to thank all the volunteers for their continued support throughout the year.
